

Customs Compliance Tool

FORWARD Belgium offers a **Customs Compliance Tool** to its members in partnership with our external partner, Sway-it.

This compliance tool is a cloudbased solution that enables you to conduct internal audits in a user-friendly way.

The **FORWARD E-contract application** gives forwarders the option to send contracts digitally and have them signed by their clients/suppliers using a legally valid digital signature. View the brochure here for more information.

The process breaks down into 10 easy steps. The **10-step plan** and accompanying **manual** can be downloaded here.

An accompanying letter has also been drawn up for FORWARD E-contract application users to use when writing their clients; this can be downloaded here.

As an added benefit, the application meets all legal requirements for digital signatures.



The Customs authority has also confirmed that it supports the use of the application for customs representation contracts.

In addition, the application serves as an ideal tool to demonstrate a direct link between customs representatives and their clients (importers/exporters).

All FORWARD Belgium members have had **free** access to this tool since 21 April 2020.

Model agreement - terms and conditions - SLA / forwarder - transporter relationship

It is a good idea to make clear arrangements to guarantee additional legal cover in any **relationship** between a **forwarder** and a **transporter**. To help you do so, FORWARD Belgium has drawn up a set of **model terms and conditions** to govern the forwarder-transporter relationship.

In practice, agreements between forwarders and transporters have often left much to be desired. By using a model agreement, the expectations of the forwarder are also taken into account and disputes can be avoided when things go wrong.



As not all forwarders want to enter into a comprehensive contract with their transporters in all circumstances, the following documents have been drawn up:

A **model SLA (service level agreement)** to be signed by both the forwarder and transporter, which mainly governs operational agreements.

A **comprehensive model agreement** to be signed by the forwarder and transporter to govern the (long-term) relationship between the two parties

Model terms and conditions (general terms and conditions) to which the forwarder can refer in its contacts with transporters. These model terms and conditions follow the opposability principle of general terms and conditions, as is the case with the General Belgian Forwarding Conditions. They can be used in addition to the General Belgian Forwarding Conditions as part of the forwarder-transporter relationship.

Customs

E-commerce

E-commerce is showing no signs of slowing down, and ever more logistics service providers are becoming involved in the organisation of ecommerce traffic. In this context, it's never a bad idea to take a moment to reflect on the potential risks associated with this type of business. Aside from potential customs risks, the logistics service provider's possible responsibility for the **safety and compliance** of

the product must also be taken into account. For more on this point, please refer to the Regulation of 20 June 2019 on market surveillance and product conformity. This Regulation states that products cannot be traded without an economic operator established in the EU taking responsibility for their safety and/or compliance. If no manufacturer, importer or authorised representative is established in the EU, the 'fulfilment service provider' will be deemed to have taken on this role.



This Regulation will enter into force partially on 1 January 2021 and in its entirety on 16 July 2021. Failure to comply or breaches may result in fines and prosecution.

The growth of ecommerce activities has also resulted in a higher risk of errors be-

ing made by customs agents. One of the main problems is **undervaluation**, with companies declaring values that are lower than what their goods are actually worth.

Customs agents can counter this risk by taking a critical look at the assignments they receive. However, determining the average value of a product remains a complex process.

FORWARD Belgium is continuing to press for the creation of a clear framework in this respect.



Direct representation

In several recent cases, the GAC&E has raised queries regarding the relationship between customs representatives and clients under the **direct representation** statute.

FORWARD Belgium has already taken a number of actions in this respect.



Brexit

On 1 February 2020, the United Kingdom officially left the European Union. On 1 January 2021, the transition period will end, and companies trading with the UK will face major taxation and customs changes.

In order to prepare companies for this as much as possible, the European Commission has published a <u>Brexit Guide for Business</u> and a <u>Brexit Checklist for Traders</u>, with steps to be taken during the preparation process.

FORWARD Belgium continues to monitor developments in this area closely.

Dual-use goods

Given the significant risks involved in the trade of dual-use goods, FORWARD Belgium has created several concise information sheets in collaboration with the Strategic Goods Control department to support compliance efforts in our sector.

We hope that these information sheets can help you increase the level of compliance at your business.



Tax representation contract

The changed VAT rules on consignment stock and chain transactions and the application of the VAT exemption to intra-community supplies (the so-called VAT Quick Fixes) entered into force on 1 January 2020.

As a result of these changes to the VAT rules, the **stand**ard tax representation contract under global number 796.5 also needed to be altered.

To assist businesses in this sector, FORWARD Belgium has amended this contract in view of the new legislation. This changed contract has been approved by the VAT authority. **CURRENT TOPICS**

We recommend that you do not just use this contract for new clients, but for existing clients too. However, we appreciate that this will present a challenge in some situations, so we have developed an **addendum** as an alternative. By signing this addendum, the client confirms that it is aware of the changes.

FORWARD Belgium members can request the new contract and the addendum from the secretariat.



Certified Pick up (CPu)

The new digital process for the release of containers, known as **certified pick-up** (CPU), will come into effect from January 2021 to replace the current PIN code release procedure. This project has its roots in the fight against drugs and crime and aims to improve safety during the delivery process at the port. The new procedure will operate via NxtPort.

All parties involved in container

handling will need to register to use the new system.

CPU will be implemented in phases. PIN codes will not immediately be shared via CPU from 1 January 2021. What will happen on that date is that container status information will become available on the basis of a BL+CTR NR combination. From the second quarter of 2021, the PIN code will be replaced by a digital release right in the CPU system.

Second-hand car byloads

Efforts are being made by the various actors at the port to ensure used vehicles can be handled and transported in a sustainable and safe manner.

The **new regulations** of the Antwerp Port Authority for **second-hand vehicle byloads** are available to download <u>here</u>. These measures will take effect on 1 January 2021.

Insurance brokerage

The **law** on **insurance brokerage** has changed The new legislation lays down a number of criteria (expertise, accreditation, training) that are unlikely to be feasible for most forwarders in practice.

A consultation has taken place between the Professional Trade Association of Insurance Brokers and the competent authority in Belgium. Following this consultation, FORWARD Belgium has issued "guidelines" for the sector and submitted these to the FSMA (Financial Services and Markets Authority).

Regardless, plenty of scope for interpretation remains and each issue largely depends on the concrete circumstances, but one thing that is clear is that increasing insurance premiums or including a 'visible' commission on them will no longer be allowed.

Based on our viewpoint and the guidelines obtained from the FSMA, FORWARD Belgium will make recommendations to the sector on how best to deal with this.



Home working policy and employment contract addendum

The introduction of remote working is a hot topic at the moment, and it is likely to become the new normal. To ensure remote working goes smoothly, clear agreements need to be made. To assist its members in this area, FORWARD Belgium has drawn up examples of both a **remote working policy** and an **employment contract addendum**.

On-the-job-training "Global Forwarding@company"

FORWARD Belgium and KdG University of Applied Sciences and Arts have designed a project around the concept of on-the-job training as part of the third year of KdG's Logistics Management course. The project will start by offering one module during the third year, but it is our ambition to incorporate on-the-job training throughout the Logistics Management course.

The focus of this on-the-job training will be on 'forwarding', and the following name was selected for the project as a result: "Global Forwarding@company".

Unlike the internship, where students apply the knowledge they have already acquired in practice, on-the-job training in an authentic and professional environment allows students to acquire the knowledge and skills that the sector expects.

This results in a clear win-win situation for both companies and for the course and its students.

Students come into contact with business practice right from the start of the course, narrowing the gap between theory and practice as a result.

Companies have the opportunity to help train their future employees and get the opportunity to deploy students in the workplace for several days a week during the course.

As a consequence, this project is bound to serve as a major stride forward in the 'war for talent' within our sector!

FORWARD Belgium and KdG University of Applied Sciences and Arts entered into mutual consultation to agree the learning objectives that students will be required to achieve in the workplace. These objectives will relate to both technical knowledge and soft skills.

On-the-job training will start in February 2021.

Digital Green Lane

A 'Digital Green Lane' was developed at BRUcargo, taking into account two of the main priorities of Air Cargo Belgium: 'Digitisation' & 'Operational Excellence'.

The BRUcargo Digital Green Lane is a standardised 'pickup & delivery' process, supported by all BRUcloud landside management applications.

BRUcure / COVID 19 vaccins

Within BRUcargo, a BRUcure taskforce has been set up to manage the transport of COVID-19 vaccines. Years of cooperation and a relationship of trust with pharmaceutical manufacturers have made Brussels Airport the preferred pharmaceutical location in Europe for this purpose.

FORWARD Belgium is in close talks with the **Port Centre** to explore how initiatives can be taken to promote our sector to young people.

Towards #ZEROPELLETLOSS together

FORWARD Belgium and its sustainability committee are fully dedicated to sustainable enterprise, and on 2 October, we organised an information session on Operation Clean Sweep, an initiative by PlasticsEurope to prevent plastic pellets in the environment.

'Pellet loss' occurs not only at producers themselves, but also during the storage and transport or their products throughout the logistics chain. Forwarders and logistics service providers can make a valuable contribution by taking measures themselves, and by monitoring compliance among their customers and suppliers.

'COVID-19 - support measures & remote working' webinar

On 8 October, FORWARD Belgium organised a **webinar** around the topic of **'COVID-19** - **support measures & home working'.**

Right from the early days of lockdown, it soon became apparent that the law in Belgium provided few answers in this type of crisis situation. As a result, the government had to take measures very quickly, but some simply came too late and others were introduced retroactively.



At the start of the lockdown, companies had no option but to switch to remote working almost instantly. This forced transition would prove to be the biggest home working experiment ever.

Various studies have shown that 8 out of 10 employers currently offer the option to work remotely. The introduction of remote working is a hot topic for companies at the moment, and it is likely to become the new normal. Employees, on the other hand, are expecting remote working to remain an option and are demanding more flexibility.

A better work-life balance, more flexibility, less stress and no more commuting were highlighted as the main reasons behind this sentiment.


On the flipside, the lack of (social) interaction with colleagues and IT system difficulties were cited as the main drawbacks of home working.

Toolkit on demurrage and detention

Under the leadership of Jens Roemer, Chair of the FIATA WG Sea, and the FORWARD Belgium Maritime Transport Committee, FIATA has launched a 'FMC (Federal Maritime Commission) final rule on demurrage and detention' toolkit.

This ground-breaking document is the result of an extensive six-year research project by the Federal Maritime Commission in the US and offers guidance for assessing whether demurrage and detention charges are reasonably applied.

Although the FMC's research is limited to the US, the principles of the document can be applied worldwide. This reference document can be used by companies to address possible abuses and is also likely to find its way into the courts ruling on claims.
