On 20 November, FORWARD Belgium and The Beacon organised an inspiring Lunch & Learn on how AI and smart logistics tools enhance efficiency, accuracy and sustainability in daily activities.

Inbound Release Platform - FAQ

To support the further roll-out of the Inbound Release Platform (IRP), we are pleased to provide the FAQ – version 1.0.0 (23 October 2025). This document was created thanks to the collaboration between Alfaport Voka, NxtPort and the Port of Antwerp-Bruges. It provides clear answers to the most frequently asked questions from logistics service providers and freight forwarders about how the IRP works.

An important part of the FAQ is the explanation of how to establish a handshake with the ship's agent.

We invite you to read this FAQ thoroughly and share it within your organisation, especially with colleagues involved in the **operational and customs handling of import shipments**.

A modern customs sanctions policy: towards greater confidence and legal certainty

Belgian customs legislation is in urgent need of renewal. It dates back to 1822, a time when trade and control were organised in a completely different way. Today, you live and work in a European context where cooperation, trust and efficiency are key. That is why the University of Antwerp, together with the University of Liège, is working on a modern customs sanctions policy that is more in line with that reality and with your daily practice as a logistics professional.

The PN/TS application must be put into use by 31 January 2026 at the latest; in order to support this special situation as much as possible, AAD&A will introduce a temporary and limited 'grace period' until 31 March 2026 at the latest.

EUDR update – General Administration of Customs & Excise

The EU Deforestation Regulation (EUDR – Regulation 2023/1115) will enter into force on **30 December 2025**. The AAD&A webpage and practical guide have been updated with information on the use of a 'conventional' reference number for due diligence statements.

On **21 October 2025**, the European Commission proposed simplifications, which are currently being discussed with the Council and Parliament. The outcome is still uncertain.

The AAD&A will announce new legal developments via its website. In the meantime, it is recommended that you prepare your **DDS numbers or Y TARIC codes** for customs declarations for goods listed in Annex 1 of the Regulation.

Update 3 - Circular on security checks PC 226

Update 3 of Circular 2025-05 on security checks in PC 226 has been distributed. It contains two additional clarifications:

- a clarification of which databases are consulted in the context of security verification;
- the addition of the new concept of positive security advice with individual warning and the associated consequences.
